



More info about visa voor non-EEA students:

When crossing the external borders, some nationals must be in possession of a visa: [Visa for non-EEA students \(including doctoral scholarship holders\) — For prospective students — Ghent University \(ugent.be\)](#)

For this course, a **short-stay visa (Schengen visa)** is needed. This course does not entitle you to a long stay student visa.

If you wish to stay in Belgium for up to 90 days, you may have to apply for a Schengen visa depending on your nationality.
